

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.neplusultrajewelry.com](http://www.neplusultrajewelry.com), and [Ne Plus Ultra](#) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to [Ne Plus Ultra](#) include [www.neplusultrajewelry.com](http://www.neplusultrajewelry.com). The [Ne Plus Ultra](#) website is a [retail jewelry sales](#) site. By using the [Ne Plus Ultra](#) website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, [Ne Plus Ultra](#) may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase [Ne Plus Ultra](#)'s products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

## Sharing Information with Third Parties

[Ne Plus Ultra](#) may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. - Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
